Illuminarium Experiences, LLC with offices at 820 Ralph McGill Blvd NE, Atlanta, GA 30306 ("Production Company"):

For good and valuable consideration, including the possibility of appearing in Production Company's production, the receipt and sufficiency of which is acknowledged, I hereby agree to the following:

Production Company and ILLUMINARIUM EXPERIENCES have my permission to use my photograph, film/video that includes me and my recorded voice and all subjects contained within, and to use those photographs, film/videotape and recordings, and my name, voice, likeness, image and information about me (collectively referred to as my "Appearance") in and in connection with the audiovisual project and any versions thereof, currently referred to as *WILD / SPACEWALK / UNTITLED FUTURE PROJECT* (the "Project"), Production Company and/or ILLUMINARIUM EXPERIENCES and the advertisements, merchandising, publicity, and promotions thereof, for any purpose including, without limitation, trade purposes, and in the exploitation of all allied, ancillary and subsidiary rights, throughout the universe at any time, in perpetuity, in any and all media now known or hereafter devised, without any compensation to me whatsoever. I represent and warrant that I have the right and authority to enter into this Agreement and to grant the rights granted herein, that I am over 18 years of age (or if under 18, my parent or legal guardian will sign below to signify consent on my behalf to the terms and conditions of this Agreement), that the rights I have granted hereunder will not violate, conflict with or infringe upon any rights of, or any commitment, agreement or understanding I have or will have with, any person or entity, that the consent of no other party is required for Production Company to exercise its rights hereunder and that it is not necessary for Production Company to pay any fees to any collective bargaining organization or otherwise in connection with my Appearance hereunder or in connection with any of the other rights in which I have granted Production Company herein. I am a volunteer and my Appearance is not employment. I represent and warrant that I gave nothing of value nor did I agree to give anything of value to anyone so I could be in the Project. I hereby release, hold harmless, and discharge Production Company, its successors, licensees and assigns, and any representatives thereof, from and against any and all claims, actions, demands, damages, losses, costs, expenses and/or liabilities of any kind or nature (including without limitation attorneys' fees and expenses) arising out of or in connection with or incurred by reason of the use of my Appearance and/or the Project and/or the inaccuracy, breach or alleged breach of any representation, warranty or undertaking I have made herein. I warrant and represent that I have freely and knowingly consented to participating in the Project and related activities with full knowledge, appreciation and understanding of the dangers and personal risks involved and hereby agree to accept any and all risks of participating in the Project.

Production Company is under no obligation to utilize my Appearance or the results and proceeds thereof. My Appearance in connection with the Project shall be deemed a work-made-for-hire specifically ordered or commissioned by Production Company under all applicable copyright laws. Production Company shall exclusively own all now known and/or hereafter existing rights of every kind throughout the universe, in perpetuity and in all languages, pertaining to such results and proceeds in and to my Appearance and the Project, and all elements therein, for all now known and/or hereafter existing uses, media, whether now known or hereafter devised, and forms, including, without limitation, all copyrights. If any of my Appearance hereunder is determined to not be a work-made-for-hire, I hereby assign to Production Company in perpetuity all right, title and interest in and to such Appearance, including without limitation, all copyrights in my Appearance (and all renewals and extensions thereof). Notwithstanding anything to the contrary contained in this Agreement, I agree that Production Company shall have the unlimited right to edit, rearrange, vary, change, alter, modify, add to, and delete from my Appearance. I hereby waive the benefits of any provision of law known as "droit moral" and/or "moral rights" or any similar law in any jurisdiction of the universe and hereby agree not to institute or support, maintain, or permit any action or lawsuit on the grounds that the Project or any ancillary uses thereof violates any of my rights or is in any way a defamation or mutilation of the product of my Appearance.

I understand that Production Company may assign the rights and/or extend this permission to third parties, in Production Company's sole discretion, in connection with any of the permitted uses indicated above, and I understand that Production Company and those others will be relying on and incurring certain expenses based on my having given Production Company this permission. I acknowledge that, other than as stated herein, Production Company has not said or promised anything to induce me to grant Production Company this permission. This permission, and all the rights granted to Production Company, are irrevocable and not subject to rescission, revocation or termination. My sole remedy for breach of any provision of this Agreement shall be an action at law for damages, and in no event shall I seek or be entitled to injunctive or other equitable relief by reason of any breach or threatened breach of this release, or for any other reason pertaining hereto, nor shall I be entitled to seek to enjoin or restrain the exhibition, distribution, advertising, exploitation or marketing of the Project. This Release shall be governed by the laws of the State of Georgia applicable to agreements made and wholly performed therein, without regard to the conflicts of law provisions thereof.
